What?

The types of personal information We collect and share depend on the product or service You have with Us. This information can include:

- · Social Security number and credit history
- · Account balances and overdraft history
- transaction history and employment information

When You are *no longer* Our member, We continue to share Your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, We list the reasons financial companies can share their customers' personal information, the reasons Meijer Credit Union chooses to share, and whether You can limit this sharing.

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.		
	Meijer Credit Union has no affiliates.		
Non-Affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.		
	Meijer Credit Union does not share with non-affiliates so they can market to You.		
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to You.		
	Our joint marketing partners include insurance companies, mortgage companies, lending companies and investment services.
